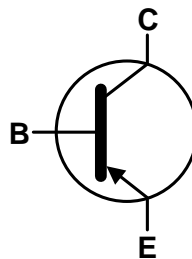

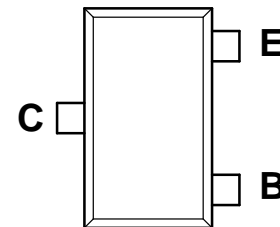

Device Symbol



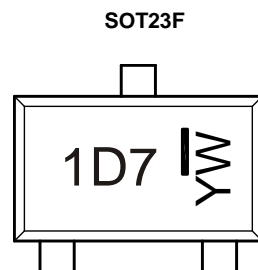
Top View
